Sub: Side collision and derailment at NTY yard in KGP Div/SER on 09.11.2023

Ref: Railway Board's letter No.2022/Elect(TRS)/113/1(Safety Misc) dated 30.11.2023

There was a side collision and derailment of light engine 28177+28565 WAG7/KGP(D) on 09.11.2023, at Nimpura (NTY) goods yard in Kharagpur Division of South Eastern Railway. During investigation of case by JAG Officers, it was noticed that cab changing procedure was not followed by LP/ALP and also proper securing of loco was not ensured by LP/ALP, causing rolling down of loco and side grazing with 2 HL BCN, resulting in derailment of two wagons.

Railway Board vide above referred letter has instructed to ensure correct cab changing procedure for single /multiple locomotives by running staff and same to be checked during field inspections and strict prompt actions to be taken against concerned staff in case of discrepancies.

In view of above, special safety drive to be launched for 15 days to counsel the crew on the above subject and ambush checks to be carried out to check whether loco running crew is following the proper procedure of loco cab changing in yard/station and securing the loco properly before cab changing.



An incident involving the rolling down of multiple locomotives occurred at the Nimpura NTY goods yard (KGP Div of SER) on 09.11.2023. The incident resulted in a side-graze with the BCN wagon, leading to the derailment of two wagons and the locomotive

The incident was discussed in Board meeting held on 15.11.2023, and it is advised that the 'Protocol for proper handling and taking over at the time of cab change should be enforced and strict prompt DAR action be taken against responsible officials.

It is, therefore, advised to ensure that the correct cab change procedure are being followed for both single / multiple locomotives by running staff & same to be checked during field inspections and strict prompt actions to be taken against responsible officials in case of discrepancies.
