As discussed in the VC of CRB, held on 06.05.2024 and GM Weekly Safety meeting held on 07.05.2024, 15 days Safety Drive from 09.05.2024 to 23.05.2024 to be launched on the subject matter. Hence, to maintenance of Fire extinguishers & Tippler operation a 15 days safety drive is being launched on the division from 09.05.2024 to 23.05.2024 involving all Officers and Supervisors of Operating, Commercial, C&W, Engineering, Safety and Supervisors (For Trippler Operation at siding) to give special emphasis to the following aspects:

## Safety Drive on maintenance of Fire Extinguisher - Special attention should be given to the following aspects-

- 1. Whether condition of Fire Extinguisher (Corrosion, defective, nozzle jammed, etc.) is found satisfactory.
- 2. Whether Fire extinguisher is overdue for refilling.
- 3. Whether adequate no. of Fire Extinguisher is available at the various installations.
- 4. Whether Fire Extinguisher is fixed at appropriate location.
- 5. Whether its operation is known to the concerned Railway staff who are normally available at the station/office.
- 6. Action taken if any discrepancies noticed

## Safety Drive on Tippler Operation at siding - Special attention should be given to the following aspects-

- 1. Whether Tippling line is provided with CCTV.
- 2. Whether the Monitor/Display is available with the tippler operator.
- 3. Whether Post Tippling line is provided with CCTV, if not, then action thereon.
- 4. Whether siding authority is ensuring that no residual material is remained in the wagon after.
- 5. Whether Tippler operator is certifying wagon wise the remnant coal etc. left.
- 6. Whether double tippling is being done, if residue left.

- 7. Whether manual removal arrangements exist, in case residual material cannot be tippled
- 8. Action taken if any discrepancies noticed.
