संदर्भ : 1. Railway Boards' letter No. 2023/Safety (A&R)/26/1 dated 24.03.2023.

2. PCSO/CR letter No. SFT/I/SD/4/CRO dated 17.04.2023.

There was a derailment of train No. 14702 Express on 16.03.2023 in Ajmer division of NWR due to cattle run over. In the financial year 2022-23, 5 Consequential and 4 Non-consequential accidents have taken place due to CRO. Data analysis of last 10 years reveals that 65 accidents took place owing to CRO. CRO incidents are a serious matter of concern and need to be tackled expeditiously.

Therefore, as directed by Railway Board and HQ, vide letters under references, a week long safety drive is being launched on the division from 19.04.2023 to 25.04.2023, involving Officers and Supervisors of Commercial, RPF, Engineering, TRO and Safety Departments.

During the period of above drive special emphasis to be given to identify following aspects mentioned under the head description and a report in the following format need be furnished to this office latest by 13:00 hrs of 27.04.2023, to enable this office to submit a consolidated report to Railway Board through HQ.

Sub: Action to be taken to control incidents of cattle run-over Ref: RB Letter No. 2023/Salety(A&R)/26/1 dated 21.03.2023

Your kind attention is drawn to the derailment of Train no. 14702, which took place on 16.3.2023 in Ajmer division, NWR, due to cattle run over (CRO). In the current financial year, 2022/23, 9 accidents have taken place due to CRO- 5 consequential and 4 non-consequential. Data analysis over a period of last 10 years (2012/13 to 2022/23), reveals that as many as 65 accidents took place owing to CRO- 35 consequential and 30 non-consequential (section wise details are enclosed herewith). CRO incidents are a serious matter of concern and need to be tackled expeditiously.

All zones have already been informed about the section-wise details of these 65 derailments over the last 10 years, vide letter under reference. On the basis of it, zones have been advised to provide safety fencing at these locations immediately, if not already done, and further identify CRO- prone locations for safety fencing on priority.

In addition to the above, it is requested that the following actions, having bearing on CRO, may also be taken up immediately on a Drive-Basis:

1. Throwing of waste by Catering/ OBHS staff on the tracks, especially near station approaches. Ambush and decoy checks need to be undertaken to control throwing of waste and deterrent penalty must be imposed on the catering/ OBHS contractor, if found engaging in such a practice.

2. A drive must be launched to identify and rectify cases of water leakages at station approaches to prevent unnecessary growth of vegetation that attracts

Lookout must be kept during footplate inspections to identify locations where there is a tendency for cattle to roam on the tracks.

4. Engineering and RPF must be deployed jointly to find out areas where cattle are let loose near tracks, to check such practices of cattle owners.

5. Disposal of garbage by the public near railway tracks must be stopped by liaising with the District Administration

Details of action taken in this regard may kindly be intimated to Railway Board.
