विषय: Mission Zero CRO-15 days divisional safety drive from 29.01.2024 to 12.02.2024.

With reference to above, a safety drive is being launched on the division from 29.01.2024 to 12.02.2024 to control the incidences of cattle run over in association with all Officers and supervisors. Emphasis should be given on action taken against the defaulters in absolute terms as mentioned in the format attached.

Efforts to be taken to visit the Villager/Panchayat etc. jointly by RPF and Engg/Optg supervisors in midsection nearly station area and counsel them regarding the effects of CRO not only on train movement but also on passenger's safety and injuries/death of the animals.

Suitable pamphlets be made in Hindi & local language for distribution to all concerned villagers/ herds man, Gram Panchayats and their head etc. Suitable FIR/penalty be imposed wherever required.

The jurisdiction/ responsibility for CRO control shall be as under –

- Station area** (In between outermost points on either side of station) **Operating & RPF.**
- other parts of section – Engineering & RPF.**

All the supervisors and staff to be counselled and sensitized on the aspects given in check list and to take suitable necessary action to avoid the same, so as to move towards Zero CROs.

A comprehensive checklist is enclosed herewith for ready reference. All officers and Supervisors associated with safety drive are advised to check these aspects during the CRO drive as per Annexure-I (enclosed herewith) and data to be filled up in the Google Form immediately after completion of inspections:
